**Explanation of Responses:**

1. Represents shares of Common Stock, \$0.01 Par Value, of Great Elm Capital Corp., a Maryland corporation (the "Common Stock" and the "Issuer"), sold by the following Mast Accounts: (i) 7,260 shares of Common Stock sold by Mast Select Opportunities Master Fund, L.P.; and (ii) 6,462 shares of Common Stock sold by Mast Credit Opportunities I Master Fund Limited
2. The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$10.32 to \$10.35, inclusive, on October 5, 2017.
3. Represents shares of Common Stock held directly by the Mast Accounts, for which MAST Capital is the investment manager, including: (i) 2,674,964 shares held by Mast Select Opportunities Master Fund, L.P.; (ii) 2,381,043 shares held by Mast Credit Opportunities I Master Fund Limited; and (iii) 156,292 shares held by Mast Admiral Master Fund, L.P.
4. As the investment advisor of certain private investment funds (collectively, the "MAST Accounts"), including those disclosed herein, MAST Capital Management, LLC ("MAST Capital") may be deemed to be the beneficial owner of the shares of Common Stock held by the MAST Accounts disclosed herein. MAST Capital also has the right to an asset-based fee relating to the MAST Accounts. Pursuant to Rule 16a-1, MAST Capital disclaims such beneficial ownership, except to the extent of its pecuniary interest therein.
5. Mr. Steinberg may also be deemed to beneficially own the shares of Common Stock beneficially owned (or deemed to be beneficially owned) by MAST Capital, as he is the principal of MAST Capital. Pursuant to Rule 16a-1, Mr. Steinberg disclaims such beneficial ownership, except to the extent of his pecuniary interest therein.
6. Represents shares of Common Stock sold by the following Mast Accounts: (i) 7,113 shares of Common Stock sold by Mast Select Opportunities Master Fund, L.P.; and (ii) 6,332 shares of Common Stock sold by Mast Credit Opportunities I Master Fund Limited
7. The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$10.31 to \$10.345, inclusive, on October 6, 2017.
8. Represents shares of Common Stock held directly by the Mast Accounts, for which MAST Capital is the investment manager, including: (i) 2,667,851 shares held by Mast Select Opportunities Master Fund, L.P.; (ii) 2,374,711 shares held by Mast Credit Opportunities I Master Fund Limited; and (iii) 156,292 shares held by Mast Admiral Master Fund, L.P.
9. Represents shares of Common Stock sold by the following Mast Accounts: (i) 1,323 shares of Common Stock sold by Mast Select Opportunities Master Fund, L.P.; and (ii) 1,177 shares of Common Stock sold by Mast Credit Opportunities I Master Fund Limited
10. The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$10.18 to \$10.24, inclusive, on October 9, 2017.
11.
