- Represents shares of Common Stock held directly by the Mast Accounts, for which MAST Capital is the investment manager, including: (i) 2,589,825 shares held by Mast Select Opportunities Master Fund, L.P.; (ii) 2,317,815 shares held by Mast Credit Opportunities I Master Fund Limited; (iii) 156,292 shares held by Mast Admiral Master Fund, L.P. and (iv) 14,115 shares held by Mast Select Opportunities, L.P.

MAST Capital also has the right to an asset-based fee relating to the MAST Accounts.
