- The price reported in Column 4 is not a weighted average price. These shares were sold in a single transaction at price of \$8.33436 on April 22, 2019.
- Represents shares of Common Stock held directly by the Mast Accounts, for which MAST Capital is the investment manager, including: (i) 1,564,246 shares held by Mast Select Opportunities Master Fund, L.P and (ii) 99,062 shares held by Mast Admiral Master Fund, L.P.
- As the investment advisor of certain private investment funds (collectively, the "MAST Accounts"), including those disclosed herein, MAST Capital Management, LLC ("MAST Capital") may be deemed to be the beneficial owner of the shares of Common Stock held by the MAST Accounts disclosed herein. MAST Capital also has the right to an asset-based fee relating to the MAST Accounts. Pursuant to Rule 16a-1, MAST Capital disclaims such beneficial ownership, except to the extent of its pecuniary interest therein.
