3. Represents shares of Common Stock held directly by the Mast Accounts, for which MAST Capital is the investment manager, including: (i) 1,363,423 shares held by Mast Select Opportunities Master Fund, L.P. and (ii) 86,685 shares held by Mast Admiral Master Fund, L.P.
